1) What are we?

We are a website (**AlphaDogs Website**) that offers to mint a collection of 3,400 digital artworks, NFT's (non-fungible tokens), from the Ethereum blockchain, of the "genesis" type.

It will also be possible to accumulate utility tokens generated by NFT's "genesis", called ALPHAS, and obtain "puppies" NFT's, exclusive to the **AlphaDogs ecosystem.**

AlphaDogs **Website only carries** out the primary mint of NFT's, therefore, if the User wants to resell the purchased NFT's , he/she must use the <u>OpenSea platform</u>.

2) Is the use of our website paid for?

No, they will only pay gas fees in the Ethereum network.

3) Is it safe to use our Website?

We try our best to make our site safe, but we still recommend that you install antivirus and protection programs before downloading any content.

4) Can these conditions be changed?

Our Terms of Use may change, but you can always access the most up-to-date version on our website. In addition, if we are going to take any action that the law requires your authorization, you will receive prior notice so that you can accept or decline.

1. DATE OF AVAILABILITY OF THE TEXT

2. EXPLANATION OF TECHNICAL OR FOREIGN LANGUAGE TERMS

2.1. he meanings of technical nomenclatures and terms in the English language are listed below.

- **NFT's:** *Non Fungible Token*, works as a kind of digital certificate, established via blockchain, which defines the originality and exclusivity of digital assets. It is an online documentation of codes, which gives ownership or rights to a digital asset that is unique and exclusive.
- **Token:** Digital certificate stored in a database called blockchain.
- **Blockchain:** It is the application of a set of technologies that guarantees the immutable record of transactions and information.
- **Non-fungible:** It is something that cannot be replaced by others of the same kind, quality and quantity, whose value, a *priori*, is not tangible, for example the NFT's.
- **Ethereum:** Decentralized platform capable of running smart contracts and decentralized applications using blockchain technology .
- **Smart contract:** or 'smart contracts' is a self-executing computer protocol.
- **Ether (ETH):** It is the cryptocurrency used in transactions on the Ethereum platform.
- ALPHA: AlphaDogs Website Utility Token .
- **Gas Fee:** Ethereum requires payment of a transaction fee (a "Gas Fee") for each transaction that takes place on the Ethereum network.
- **Virus:** Malicious software that infects systems and computers, with the objective of causing some damage, makes copies of itself and tries to spread itself to other computers, using different means.
- User: One who uses the AlphaDogs Website.

3. SERVICES

3.1. **What we are:** The **AlphaDogs Website** consists of, but is not limited to, a Website that offers for sale a collection of 3,400 digital artworks, NFT's (non-fungible tokens), from the Ethereum blockchain, of the "genesis" type.

3.1.1. It will also be possible to accumulate utility tokens generated by NFT's "genesis" and obtain "puppies" NFT's, exclusive to the **AlphaDogs** ecosystem.

3.1.2. AlphaDogs **Website** is not a marketplace platform and only performs the primary mint of NFT's, therefore, if the User wants to resell the purchased NFT's, he/she must use the <u>OpenSea platform</u>.

3.2. When using the **AlphaDogs Website**, Users must understand and accept that all their actions and choices are free and do not have any kind of influence or interference from **AlphaDogs Website**.

3.3. It is hereby clarified that this service does not establish any employment, corporate or associative relationship between the parties, each party remaining solely responsible for all their respective expenses and charges, whether of a labor, social security, tax, insurance, civil, criminal or any other nature or species.

3.4. The use of the Website is **only allowed to people over 18 (eighteen)** years old and **AlphaDogs Website** will make reasonable efforts to confirm this data, but is not responsible if the User does not have the minimum age described herein.

4. PAYMENT

4.1. Users will only pay gas fees in the Ethereum Network.

4.1.1. There will be only 3,400 NFTs of the "genesis" type, initially as a FREE mint.

4.1.2. Commissions ('royalties') will also be charged on secondary sales of NFT's of 7,5% (six percent) on each sale made through the OpenSea platform.

4.2. Each "genesis" NFT, from the date of purchase, will generate 10 (ten) utility tokens ('ALPHA') per day. The User who accumulates 1,800 ALPHAS will be able to acquire a "puppy" NFT within the **AlphaDogs Website ecosystem**

4.2.1. "Pup" tokens can only be minted on the **AlphaDogs Website** if the User accumulates the number of ALPHAS mentioned above.

4.3. To make a transaction on the Ethereum network, the User must use the MetaMask digital Wallet.

4.4. To free mint NFT's on our Website, the User must select the desired collectibles and "mint" NFTs from the AlphaDogs collection. To do so, you must

connect your Wallet, activate the browser plug-in, select the NFT you want and click on "mint". This will open the Metamask to confirm and complete the transaction.

4.5. Any transactions necessary for the mint of NFT'S from **AlphaDogs Website** will be carried out exclusively through the Ethereum network.

4.5.1. AlphaDogs **Website has** no responsibility or control for the financial transactions carried out for the purchase of NFT's.

4.5.2. The User is responsible for paying the Ethereum network transaction fee "Taxa Gás", which may vary depending on network traffic at the time of purchase.

5. RESPONSIBILITY OF THE PARTIES

5.1. AlphaDogs Website Responsibility:

5.1.1. Perform the services as described in these Terms of Use;

5.1.2. Be responsible for the website good functioning and for any corrections that may be necessary;

5.1.3. Inform any change in the services to Users through simple communications on the website.

5.2. Users Responsibilities:

5.2.1. Use the site according to the usage criteria defined by **AlphaDogs Website** without changing its programming, breaking passwords or performing procedures that may cause damage to **AlphaDogs Website** , other Users and third parties;

8.1.1. Blockchain technologies and digital assets such as NFT's are new, experimental and speculative and therefore there is significant uncertainty as to how they work and their effects and risks and the enforcement of existing legislation.

8.1.2. The prices of NFTs are extremely volatile and fluctuations in the prices of other NFTs affect the price of the NFT purchased on the **AlphaDogs Website**, both positively and negatively.

8.1.3. AlphaDogs **Website relies** on public peer-to-peer networks, such as Ethereum, which are not under its control or influence and are subject to many risks and uncertainties.

9. OUTCOMES OF ACCESS TO THE SITE

9.1. Despite **AlphaDogs Website's** best efforts to provide the best technologies to maintain online connection and synchronization and secure access to Users, due to technical difficulties, internet applications or transmission problems, inaccurate or incomplete copies of the information contained in the site.
